SKIN	REMOVE CONTAMINATED CLOTHES AS QUICKLY AS POSSIBLE, PROTECTING YOUR OWN HANDS AND BODY. IF IRRITATION PERSISTS, SEEK MEDICAL ATTENTION. WASH CONTAMINATED CLOTHING BEFORE REUSING.
EYE	CHECK FOR AND REMOVE ANY CONTACT LENSES. IMMEDIATELY FLUSH EYES WITH RUNNING WATER FOR AT LEAST 15 MINUTES, KEEPING EYELIDS OPEN. COLD WATER MAY BE USED. DO NOT USE AN EYE OINTMENT. SEEK MEDICAL ATTENTION.
INHALATION	EVACUATE THE VICTIM TO A SAFE AREA AS SOON AS POSSIBLE. LOOSEN TIGHT CLOTHING SUCH AS A COLLAR, TIE, BELT OR WAISTBAND. OXYGEN MAY BE ADMINISTERED IF BREATHING IS DIFFICULT.
